Dear Parent/Carer,

Re: Year 13 Study Leave 2024

I hope this correspondence finds you and your family well. As we work towards the end of a demanding but highly productive spring term, I would like to take this opportunity to confirm the arrangements for the forthcoming A Level examination period starting on Thursday 2 May 2024 and finishing on Friday 21 June 2024. All candidates must also be available on Wednesday 26 June 2024 as it is the National Contingency date and, as such, could be used in the unlikely event of any examinations having to be moved by the Joint Council for Qualifications (JCQ).

Summer Term 1 - Monday 15 April to Friday 24 May 2024

As you are aware, the A Level examination period commences on **Thursday 2 May 2024**, where upon Year 13 students will be required to attend their examinations as outlined on their individual Statement of Entry form which you received in January. When students are not sitting an examination, they will be required to follow their normal timetable and attend all lessons.

Where subjects have completed their final examinations before Monday 3 June 2024 these lessons will be given over to other subjects and revision sessions for the next examinations. We believe that these arrangements will enable the students to focus on their studies and maximise their opportunities to achieve success.

Summer Term 2 - Study Leave - Monday 3 June to Friday 21 June 2024

'Study Leave' will commence on **Friday 24 May at 3.10 pm** and this will permit Year 13 students to independently revise at home when they are not sitting an examination.

Whilst we appreciate that many of our Year 13 students possess the necessary revision skills and high levels of motivation to successfully adopt a self-study approach, we also recognise that some students can struggle to make the best use of unsupervised and unstructured revision time. Therefore, we would like to offer all Year 13 students the opportunity to attend revision lessons in all subject areas up until their final examination so they can continue to access relevant revision support and guidance from their subject staff during the academy day.

Structured Revision Support

Structured revision support will take place during normal timetable lessons from **Monday 3 June 2024** and Year 13 students are asked to arrive to lessons promptly to maximise the time available.

For health and safety/safeguarding reasons if students elect to attend revision sessions they are asked to sign in and out at the College Office. Students are not required to sign in when they have an A Level examination as registration will be taken at the start of the examination.

Extra-Curricular Revision Sessions

We have been delighted with the number of Year 13 students who continue to engage with the extra-curricular revision sessions across a vast array of different subject areas. It is also important that students continue to be proactive and liaise with subject staff about the scheduling of these sessions during the examination period.
